If the Board of Revenue Sindh finds that the concerned organization does not exist or the experience certificate(s) are detected bogus later on, and in such case, if the experience falls short of the required length, then the candidate shall be rendered ineligible.

Those candidates who have secured less than 33 marks out of a total of 100 marks have been declared "Incompetent", and not recommended.
